

Frequently Asked Questions

Who is Jones Day and how long has Jones Day been in China?

What are Jones Day's practices in China?

What is the Jones Day International Legal Fellowship?

Since Jones Day's founding in 1893, we have been focusing on identifying, developing, and nurturing outstanding lawyers, and the Jones Day Fellowship is designed to identify and support outstanding legal talents in China. Since 2001, Jones Day has awarded a total of 255 Fellowships and over 4.5 million Renminbi of scholarships to those exceptional law students in China.

Who can apply for the Fellowship?

The competition is open to all graduate students and undergraduates in their third year or above studying law at universities in China. Previous Jones Day International Legal Fellowship winners are not eligible for consideration.

When is the deadline for applying for the Fellowship?

The deadline for applying for the Fellowship is May 7, 2024. Applicants must ensure that their application form be filled and submitted on or before the deadline. Late applications will not be considered.

How are the winners decided?

We focus on identifying outstanding legal talents, not necessarily on the best academic record. Fellowship winners are chosen not only for their outstanding intellect, but also for their character and potential for working at the highest level of legal practice.

What do the Fellowship winners receive?

2024 Fellowship winners will receive a RMB35,000 scholarship, a Jones Day Fellowship certificate, and a possible Jones Day internship with our Beijing or Shanghai Office.

How do I apply for the Fellowship?

The application period for the 2024 Fellowship will begin on April 16, and end on May 7, 2024. To apply, please fill in the [Application Form](#) online and submit the information and materials required.

What information/materials should I submit to apply for the Fellowship?

Applicants should submit the following information:

- A 2-minute video in English containing a presentation on any legal-related topic(s) you like and a brief self-introduction (previous application video can't be used).

- Personal Information Sheet.
- Your most current transcript with your school's official seal.

Is there any size limit or requirements for the materials I upload?

The maximum upload size is 25MB in total. Name your file as "JD Fellowship+your name+nature of the file (video, CV, transcript, etc.)".

Why do I fail to upload my video?

Due to network restrictions, if you encounter the issue of being unable to upload, please try to compress the file size as much as possible while making sure that the video is clear and try again during non-busy hours.

How do I know if I submit the information successfully?

Valid applicants will receive email confirmations within one week after submission.
